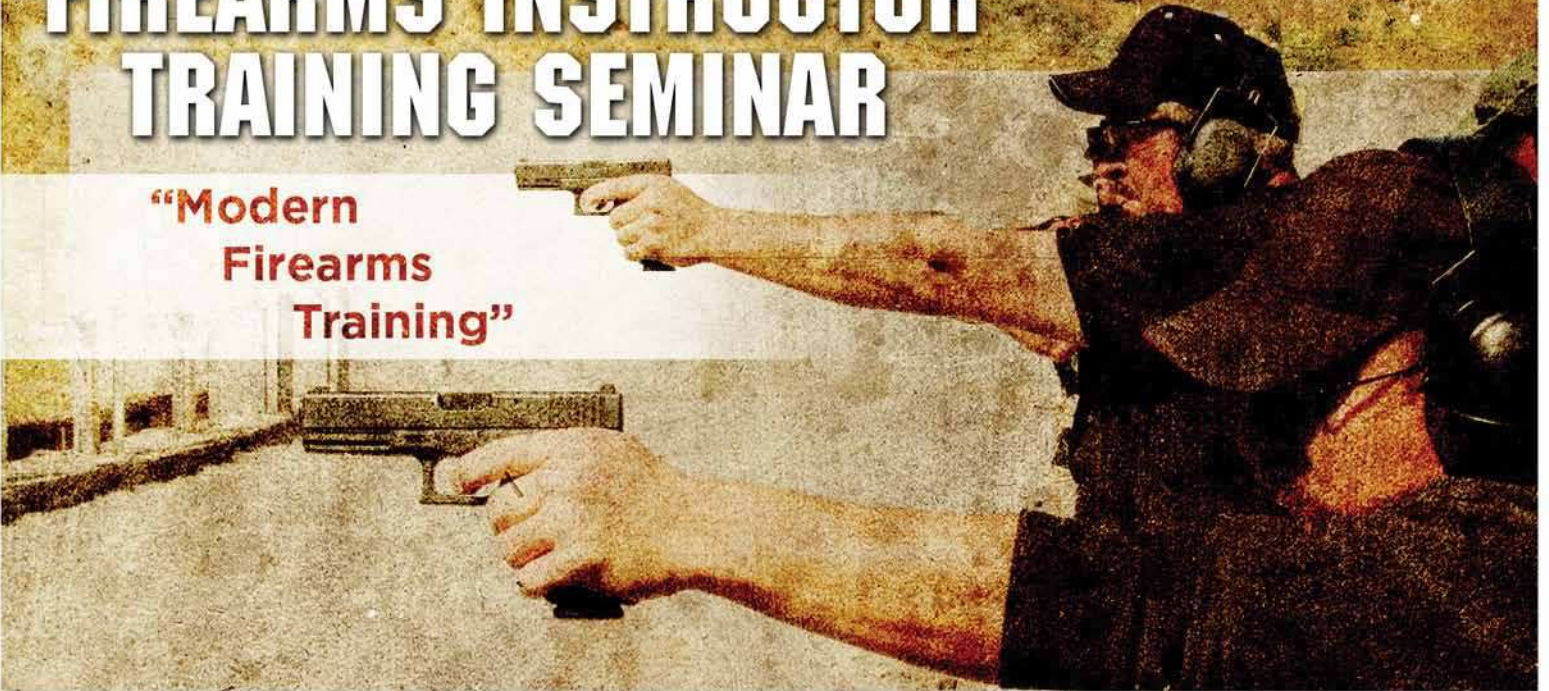

- **SHOOTING RANGE EQUIPMENT:** We will discuss how proper range equipment can help you meet the standards and goals presented throughout the day.
- **THE REALITIES OF TODAY’S GUNFIGHTS:** We will review and analyze current law enforcement gunfight statistics, plus the physical and mental responses to combat stress. We will then determine how the results should shape your firearms training standards, practices, and policies.
- **QUALIFICATION VS. TRAINING:** What are the differences? Learn why an understanding of these issues is so important and why you do not have to settle for one or the other
- **PUTTING IT ALL TOGETHER:** Action Target Academy trainers will reinforce the classroom material through live-fire exercises designed for real life application and success.
